



The Caribbean Biodiversity Fund

2. The Caribbean Biodiversity Fund

The Caribbean Biodiversity Fund (CBF) is a conservation trust fund established in 2012 to create reliable, long-term funding for conservation and sustainable development in the Caribbean region. The CBF uses a flexible structure to facilitate and implement innovative solutions and consolidate resource mobilization in the Caribbean through a range of financial instruments.

Working towards the vision of a Caribbean region where both its natural environment and people thrive, the organization measures total assets under management, annual return on investments, competency improvements, and reporting to global initiatives as its key performance indicators. Currently, the CBF has three programs:



The Conservation Finance

Under the Conservation Finance Program, the CBF manages an Endowment Fund that invests funding for long-term conservation and provides support and financial resources to eligible partner National Conservation Trust Funds (NCTFs) that lead the grantmaking process at the national level. This Program also includes an organizational development component that strengthens the network of these partner NCTFs that together with the CBF form the Caribbean Sustainable Finance Architecture (CSFA). Activities financed by the Conservation Finance Program include support for the establishment and improved management of protected areas, infrastructure within and outside protected areas for natural resources management, environmental education, community engagement, environmental policy, and research. The Endowment Fund to date has also been able to respond to relief efforts to restore biodiversity after climatic disasters, such as hurricanes and volcano eruptions.









The Climate Change Program, through its Ecosystem-based Adaptation (EbA) Facility, awards grants directly to local, national, and regional projects through competitive calls for proposals that support effective climate change adaptation measures in the insular Caribbean. Eligible grantees include non-governmental organizations (NGOs), community-based organizations (CBOs), government agencies, regional

organizations, private sector companies, universities, other academic institutions, and consortia of organizations. Funding for the EbA Facility was contributed by the Government of Germany through the German Development Bank (KfW) and the International Climate Initiative (IKI) of the German Federal Ministry for the Environment, Nature Conservation, Nuclear Safety, and Consumer Protection (BMUV).



The CBF's Nature-Based Economies (NbE) **Program** was developed to address the reduction of pollution in the region. The Advancing Circular Economy (ACE) Facility which falls under the NbE Program, promotes marine litter management in the insular Caribbean. The ACE Facility will work with public and private sector partners as well as other Caribbean stakeholders to fund projects that promote and apply practical circular economy principles to minimize and prevent waste from entering the marine environment and/or removing marine litter. This is to be achieved by investments in equipment and infrastructure and the generation of data and knowledge, policy support, and the education of consumers. The ACE Facility is funded through a sinking fund from the KfW on behalf of the German Federal Ministry for Economic Cooperation and Development.

Additionally, the CBF has developed a number of strategic projects that are working through the CSFA, other partners and beneficiaries to create consolidated, investible national and regional organisations for strategic sustainable financial mechanisms. This is a major thrust as part of the organization's strategic approach to improve national and regional competencies. To date, the CBF strategic project partners include: Agence Française de Développement (AFD) / Fonds Français pour l'Environnement Mondial (FFEM), Global Affairs Canada, Global Environmental Facility, Blue Nature Alliance and U.S. Agency for International Development (USAID).





Participation at SIDS4

CBF participated in the 4th International Conference on Small Island Developing States UN (SIDS4) conference held in Antigua and Barbuda in May 2024. The CBF delegation included 4 team members and Board Chair Karolin Troubetzkoy. At the SIDS4 Conference, the team achieved the following key outputs.

The CBF hosted the "Blue Futures: Pioneering Sustainable Finance Models for Coastal Conservation in the Caribbean and Beyond" side event, focusing on innovative financial solutions for marine conservation.

- The CBF co-hosted the "Forging Partnerships for the Future: Achieving the GBF 30x30 Target" side event with The Nature Conservancy, emphasizing regional partnerships and steps towards meeting biodiversity targets. Highlevel participation of the Ministry of Environment of Grenada.
- The CBF delegation engaged in discussions on blended finance for MPA management, blue carbon sequestration, blue economy financing, disaster risk management, sargassum management and deepsea mining impacts as well as, publicprivate collaboration with individuals and organizations like GEF, McKinsey & Co., and UNDP/GEF PROCARIBE+.

 The delegation also promoted the 2024 Congress of the Network of Environmental Funds for Latin America and the Caribbean (REDLAC) conference to be hosted in Saint Lucia by organizers: Saint Lucia National Conservation Fund (SLUNCF), Caribbean Biodiversity Fund in affiliation with REDLAC.



Practice Standards Assessments

In 2024, consultants supported assessments of the CBF and 11 NCTFs using the 2020 Standards of Practice for Conservation Trust Funds Tool. These organizations were analyzed across seven core competencies: governance, institutional effectiveness, programs, administration, asset management, resource mobilization, and risk management and safeguards. The resulting recommendations included Organizational Strengthening Plans and End-of-Agreement Evaluations that prioritized improvements in weak areas. Among the organizations' strengths were governance, Institutional effectiveness, programs and administration while weaknesses were resource mobilisation and risk management areas.

Caribbean Environmental Film and Arts Festival (CEFAF)

The 2024 Caribbean Environmental Film and Arts Festival (CEFAF) successfully expanded the CBF's reach and impact, leveraging film, poetry, visual arts, and live performances to promote environmental awareness across the region.

The festival showcased 17 films from nine Caribbean nations, alongside 12 poetry performances, 11 live acts, and 19 visual art pieces, enriching cultural dialogue on sustainability. The participation of 61 filmmakers from 20 countries further solidified CEFAF's reputation as a key regional event blending art and environmental advocacy.

Through its growing audience engagement and diverse artistic contributions, CEFAF

continues to strengthen the Caribbean Biodiversity Fund's commitment to fostering environmental consciousness through creative expression.





Bahamas Hurricane Dorian Recovery Support

The Bahamas Hurricane Dorian Recovery Grant, supported by the German Federal Ministry and administered by the Caribbean Biodiversity Fund, successfully allocated \$1.26 million to aid recovery in Abaco and Grand Bahama.

Despite challenges such as COVID-19 restrictions and supply chain issues, the project fostered substantial community engagement and educational initiatives, setting a strong foundation for continued ecological and community recovery.

Significant achievements included the restoration of mangrove ecosystems with over 22,000 plants, the installation of solar energy systems in educational institutions, and the drafting of recovery plans for both bottlenose dolphins and national parks. The grant also contributed to building capacity and global biodiversity goals and supported numerous sustainable development goals (SDGs) like clean energy and life below water.





3.1 | Conservation Finance Program


The Conservation Finance Program is supported by the CBF Endowment Fund and a range of strategic projects.

Contributions to the Endowment Fund are invested in country-based sub-accounts and channeled through partner National Conservation Trust Funds (NCTFs), who in turn lead grantmaking programs at the national level. The Conservation Finance Program also provides organizational development support to strengthen the network of NCTFs that together with the CBF form the Caribbean Sustainable Financial Architecture (CSFA).

At the end of the financial year, the endowment fund had a market value of USD 100 million, from which USD 9.3 million has been disbursed to partner NCTFs since its establishment in 2012.

To date, the Conservation Finance Program is supported mainly through the CBF Endowment Fund benefitting 12 countries.






3.2 | CBF's Strategic Projects: Strengthening The Caribbean Sustainable Financial Architecture (CSFA)


The CBF has fostered strategic partnerships that offer additional funding avenues through regional projects, further promoting sustainable development in the Caribbean.

At the end of the 2024 financial year, the total value of these partnerships reached USD 21 million, thanks to contributions from six financing partners. These partners include the French Agency for Development (AfD), Blue Nature Alliance (BNA), Fonds français pour l'environnement mondial (FFEM), Global Affairs Canada (GAC), Global Environment Facility (GEF) and the United States Agency for International Development (USAID). These regional projects play a pivotal role in strengthening the Caribbean Sustainable Finance Architecture (CSFA), an organizational development component of the CBF's Conservation Finance Program.













3.2.1 | Caribbean Regional Architecture for Biodiversity (CRAB) Project


The Caribbean Regional Architecture for Biodiversity (CRAB) Project supports the maintenance and restoration of Caribbean Biodiversity and its natural resources in the long term. The CRAB project started in July 2022 and will run for 5 years.

3.2.2 | Caribbean Blue Economy Financing (Caribbean BluEFin) Project


The Caribbean Blue Economy Financing (Caribbean BluEFin) Project objective is to create and strengthen nature-based Blue Economy opportunities and approaches in the Caribbean through innovative financing mechanisms. The project will also engage stakeholders and raise awareness about sustainable blue economy within the region.

3.2.3 | The Caribbean Organizations for a Resilient Environment (CORE) Project


The Caribbean Organizations for a Resilient Environment (CORE) Project will support the mainstreaming of inclusive and gender responsive approaches within the Caribbean Sustainable Finance Architecture (CSFA). This will expand the reach and results of the project beneficiaries at the national, local and community levels which in turn increases the climate change resilience of Caribbean communities. The CORE project includes the Gender Smart Facility that will channel additional grant funds to the NCTFs in the beneficiary countries for gender sensitive, climate resilience projects. The project will run for 4 years, from April 2023 to December 2027.

Belize, Dominica, Grenada, Guyana, Jamaica, St. Lucia, St. Vincent and the Grenadines, Suriname

3.2.4 | Effective Marine Protected Area Activities for the Caribbean (EMPAC) Project

The Effective Marine Protected Area Activities for the Caribbean (EMPAC) Project places particular focus on improved management and sustainable financing mechanisms of Marine Protected Areas in the Caribbean. As such, the project is designed to support regional political engagement towards the 30x30 ambition, and the design and launch of a CBF MPA Facility in collaboration with Caribbean stakeholders. The project started in May 2023.

Results Achieved To Date:

- The CBF co-hosted the preparatory meeting of government officials for the Biodiversity Conference, organized in September 2024 in Miami, together with CARICOM and the OECS.

3.2.5 | USAID Sustainable Financing for Caribbean Regional Conservation Project


The USAID Sustainable Financing for Caribbean Regional Conservation Project was established with the main objective of ensuring that the conservation of ecosystems in the Caribbean region is safeguarded through sustainable financing. This project will facilitate the growth of the Caribbean Sustainable Finance Architecture through the continued development of the CBF's partner NCTFs. As national conservation leaders in their own countries. this will increase their contribution to resource mobilization for biodiversity, protected areas and environmental management priorities. The USAID project started in August 2023 with the official kickoff in January 2024.

The Bahamas, Dominica, Dominican Republic, Grenada, Guyana, Haiti, Jamaica, St. Kitts and Nevis, St. Lucia, St. Vincent and the Grenadines, and Suriname

3.3 | Climate Change

The Climate Change Program promotes the use of biodiversity and ecosystem services for effective climate change adaptation within the Caribbean. Ecosystem-based Adaptation (EbA) measures help to mitigate the adverse effects of climate change, reduce disaster risk, as well as build resilient ecosystems and economies. In December 2023, additional funding was provided by the International Climate Initiative (IKI) of the German Federal Ministry for the Environment, Nature Conservation, and Nuclear Safety, and Consumer Protection (BMUV) that enabled a 3rd Financing Agreement to be signed with KfW and brought the total inflows to the EbA Facility of EUR 55 million. The new financing will facilitate a 5th Call for Proposal (CfP) and extends the EbA Facility's lifespan to the end of 2030. As at 30 September 2024, the market value of the EbA Facility sinking fund stood at USD 60 million.

Since the inception of the CBF EbA Facility in 2016, four calls for proposals have been completed, resulting in a total of USD 45.4 million committed to 34 Caribbean EbA projects, with a further USD 15 million earmarked for six to eight projects under the 5th CfP. A total of USD 26,120,723.63 million have been disbursed to date.

CBF EbA projects target coastal and marine ecosystems such as mangroves, wetlands, coral reefs, and coastal watersheds and will benefit at least 40 protected areas. These projects assist in climate change adaptation, protection of the Caribbean region's ecosystems thus building strong and resilient economies. Eleven grants were awarded under the first CfP, eight under the second, seven each under the third and fourth calls for proposals. EbA Facility's Projects by Country Investments




3.3 | Climate Change



In FY24, three projects under the 2nd CfP were concluded successfully. Their highlights were:

- The Fundación Rural Economic Development Dominicana (REDDOM) improved the management of coastal and marine ecosystems in the Limón and Redonda lagoons wildlife refuges, and nearby areas in Miches, Dominican Republic, to increase resilience of people to hurricanes and storms and to protect biodiversity. A total of 2,016 people (940 women) were directly supported to adapt to climate change or to conserve ecosystems. The project rehabilitated 142ha and improved or protected 728 ha.
- The Ocean Foundation (TOF) improved 1,431.5 ha and restored 470 ha of mangrove habitat in Cuba. The replanting of approximately 46,485

sexually fertilized coral polyps and the return of 786 staghorn coral fragments accounted for approximately 1.5 ha of restored coral habitat in Cuba and the Dominican Republic. Carbon insetting led to 1,420 tons of greenhouse gas emissions prevented through the collecting and composting of sargassum in both countries.

The Windward Islands Research & Education Foundation (WINDREF) achieved significant milestones in environmental restoration and community capacity building in Grenada. A plant nursery supported the cultivation and outplanting of over 3,000 native species to restore ecosystems, with survival rates up to 80%. Coral reef restoration included establishing a coral nursery and training eight assistants in microfragmentation and outplanting techniques. Additionally, 117 meters of shoreline were stabilized using gabion baskets, boulders, and native vegetation. This held up remarkably well during Hurricane Beryl in July. Community engagement was central to all project activities, fostering local stewardship and sustainable practices.

To date over 22,000 persons have benefited directly from the programme's activities, 5,000 of whom through enhanced livelihood opportunities. Over 30,000ha of ecosystem area has been improved or protected by EbA interventions.

FY24 highlights of the EbA Facility included the roll-out of the CBF Environmental and Social Management System (ESMS) for arantees under the 3rd and 4th CfP and the initiation of a carbon accounting consultancy, which is implemented by Climate Focus and co-managed by the Panamerican Development Foundation (PADF). This consultancy will help EbA past and present grantees to quantify the carbon sequestered and emissions avoided. This will allow the CBF to report against the associated IKI indicator. The EbA Facility shared its insights and lessons learned at the EbA LINKup session entitled: "Proven Successes of Ecosystem-based Adaptation (EbA) Measures Implemented in the Caribbean" in August 2024.



3.4 Nature-Based Economies

The Nature-based Economies (NbE) Program was developed around a new Advancing Circular Economy (ACE) Facility designed to contribute to the prevention and reduction of marine litter in the insular Caribbean. Initiated as a five-year sinking fund, the ACE Facility is a financing mechanism for circular economy interventions in the Caribbean. Through a competitive Call for Proposals (CfPs) mechanism, the ACE Facility will support circular economy projects aimed at reducing marine litter and strengthening the capacities and awareness of public and private stakeholders in the Caribbean. This will involve investments in equipment. infrastructure, policy support, the education of consumers, and the generation of data and knowledge. Grants will be awarded to projects that apply circular economy principles to prevent litter from entering the marine environment or to remove marine litter.

The ACE Facility is funded by the German Federal Ministry for Economic Cooperation and Development (BMZ) through the KfW Development Bank (KfW).

The geographical focus of the projects includes Cuba, Dominica, Dominican Republic, Grenada, Haiti, Jamaica, Montserrat, St. Lucia, and St. Vincent and the Grenadines. Eligible grantees are non-governmental organizations, academia, public institutions, community-based organizations, and small and medium-sized enterprises (SMEs) in the private sector.











The ACE Facility will support projects that:

- Promote and apply practical circular economy principles to minimize and/ or prevent waste from entering the marine environment.
- Promote and apply practical circular economy principles to remove marine litter and consider the processes after waste removal for proper disposal of waste such as recycling, reuse, refurbishing, etc.

The above should be complemented by activities that support knowledge and data generation on the topics of the circular economy and marine pollution in the Caribbean region, activities that promote

the sustainable approach to ACE Facility projects ensuring they operate financially independent by the end of the project, and activities that formulate new or strengthen existing partnerships that promote the circular economy in the Caribbean.

The ACE Facility has transitioned into an active implementation phase from 2023 to 2024. The Facility launched its first CfPs in August 2024. Good reach and success was demonstrated via the response to the CfPs 1 where a total of 77 Concept Notes were received and sixteen (16) were advanced to the Full Proposal Phase with the projected execution of interventions anticipated in March 2025. The ACE Facility also expects to execute its second CfPs in 2025.







Expanding CBF's Reach



Social Media Growth & Engagement

CBF's digital presence grew significantly in 2024, with a 13.2% increase in published content and over 416,000 impressions—a testament to the expanding reach of our conservation messaging. Social media served as a key platform for amplifying job opportunities, funding announcements, and thought leadership, with career-related content driving the highest engagement.



Media Coverage & Thought Leadership

With 30 press mentions, CBF maintained strong media visibility in 2024. Stories featuring the organization ranged from financial innovation in conservation (The Daily Herald) to sustainable beekeeping in Samaná (Dominican Today) and shorebird conservation in Anguilla (Global Voices). These features reinforced CBF's role as a regional leader in biodiversity finance and sustainable development.



Strategic Campaigns: RedLAC Congress & ACE Facility

Two standout campaigns defined 2024:


- The promotion of the 2024 RedLAC Congress, where CBF played a key organizational role alongside SLUNCF, significantly boosted engagement and positioned the event as a major platform for conservation finance discussions.
- The launch of the ACE Facility's first call for proposals generated widespread interest among stakeholders, underscoring the demand for funding opportunities in ecosystem-based adaptation.


